I give to my wife Sarah Fountain all my lands stock and Chattles during her life except fifty Acres of land above the little lake Brook which I give to Peter Raymond with my waring apparel and four sheep, and after the decease of Sarah Fountain, I give to Stephen Fountain Eldridge, all my lands stock and Chattles exclusive the land given to Peter Raymond and four sheep, and a yoke of Oxen and four sheep I give to John Squire Eldridge, also I give to Mary Eldridges Daughters at Sarah Fountains decease all my house Hold Furniture, And I make and ordain John Morehouse Esq. sole executor of this my last will contained in trust for the intent and purpose in this my will contained and I make my friends overseers of this my will to take on and see the same performed according to my intent and meaning and witness whereof hence I the said Stephen Fountain have to this my last will and testament sett my hand and seal the day and year above so written signed sealed and delivered by the said Stephen Fountain as for his last will and testament in the presence of us who witness of the signing and sealing Samuel Morehouse jr.
