I have certificate for proof of descent from John Yerxa/Jurckse, loyalist from Cortlandt Manor, Westchester Co., New York, who settled in 1788 on land at Keswick, York Co. New Brunswick.

A copy of one of his petitions/Memorials to the Commissioners follows. I found this one particularly interesting.

## To the Commissioners

Appointed by Act of Parliament for enquiring into the Losses and Services of the American Loyalists.

## The Memorial of John Yerxa,

Humbly sheweth,

That he has ever been Loyal and hath suffered much by reason thereof. That he was aiding and assisting His Majesty in the support of his Government by every endeavour in his Power whilst within Rebel Lines and from the commencement of the War.-

That he was driven within the British Lines in 1780 when he joined the Refugees under Colonel Delancey, in which service he continued till he came to the Province of Nova Scotia now New Brunswick.

He therefore hopes the Honorable Commissioners will consider his Sufferings, his Losses and Loyalty and make him such Recompense as to them shall hereafter appear Equitable and Just.

And as in Duty bound shall ever pray.

Says, he came in August, went to Magerville.-Sent by Captain

Vanderburgh, could not send before.-

Lived on Cortlands Manor, joined the British in the year 1780.

Served with Colonel Delancey as Volunteer.-

Property. One cow taken by Continental Militia, Lost one after he got within

The Lines, he bought her and carried her in.-

Lost cash taken from him and money spent in Prison.-

### William Free Sworn,

Claimant served under Colonel DeLancey, knew the Rebels took a Cow from him for his not serving in Militia, this was in 1778 two years before he went within the Lines.-
